ORDER

WHEREAS, pursuant to Florida law the Office of Criminal Conflict and Civil Regional Counsel, First District (hereinafter **RCC1**) is to be appointed on all conflict cases, civil and criminal, within the First Judicial Circuit effective January 1, 2008; and

WHEREAS, RCC1 has been delayed for various reasons from becoming fully operational and it is has been necessary for this Court to administer the incremental development of RCC1 in the First Judicial Circuit; and

WHEREAS, the **RCC1** has notified this court of its ability to accept appointment of all applicable case types in Escambia County, all applicable case types in Santa Rosa County, limited case types in Okaloosa County and limited case types in Walton County, it is hereby

ORDERED:

Effective **July 2, 2012** and until further notice by this Court, the Judges in **Escambia County** shall appoint the RCC1 in **all conflict cases, civil and criminal, with the exception of capital death penalty cases and death penalty appeals.**

Effective **July 2, 2012** and until further notice by this Court, the Judges in **Santa Rosa County** shall appoint the RCC1 in **all conflict cases, civil and criminal, with the exception of capital death penalty cases and death penalty appeals.**

Effective **July 2, 2012** and until further notice by this Court, the Judges in **Okaloosa County** shall appoint the RCC1 in **all conflict adult felony criminal cases with the exception of capital death penalty cases, and shall appoint the RCC1 in all conflict civil dependency cases including termination of parental rights.**

Effective **July 23, 2012** and until further notice by this Court, the Judges in **Okaloosa County** shall appoint the RCC1 in **all conflict cases, civil and criminal, with the exception of death penalty and death penalty appeals.**

Effective **July 2, 2012** and until further notice by this Court, the Judges in **Walton County** shall appoint the RCC1 in **all conflict adult felony cases with the exception of capital death penalty cases, and shall appoint the RCC1 in all conflict civil dependency cases, including termination of parental rights.**

Effective **July 23, 2012** and until further notice by this Court, the Judges in **Walton County** shall appoint the RCC1 in **all conflict cases, civil and criminal, with the exception of death penalty and death penalty appeals.**
