ATTENDANCE OF COMMITMENT MANAGERS AT DISPOSITIONAL HEARINGS

**WHEREAS**, disposition hearings are governed by Section 985.43 and Section 985.433, Florida Statutes; and

**WHEREAS**, the Department of Juvenile Justice (Department) is a party to each delinquency case; and

**WHEREAS,** under Section 985.43(2), Florida Statutes, the Court shall consider the Pre-Disposition Report (PDR) provided by the Department before making a final disposition of the case; and

**WHEREAS**, under the governing statutes the Court may receive and consider at a disposition hearing material evidence including, without limitation, written or oral reports or statements it deems relevant for purposes of the disposition; and

**WHEREAS**, the Department's "Commitment Manager" conducts a multidisciplinary commitment conference (also known as a "staffing") for each juvenile who is being considered for a residential commitment for the purpose of making a recommendation to the Court as to the appropriate level of commitment; and

**WHEREAS**, the Court deems statements of the Commitment Manager, as to the basis of the recommendations made by the Department in the PDR, to be relevant for purposes of disposition, it is

## **ORDERED** that:

1. The Commitment Manager or the Commitment Manager's designee with knowledge as to the basis for the Department's commitment recommendation in the PDR shall be present at any dispositional hearing following the multidisciplinary commitment conference at which the Court is considering commitment.

2. The Commitment Manager or the Commitment Manager's designee may appear at the dispositional hearing via Zoom unless otherwise ordered.
