- 3. When filing a **Petition for Discharge**, the checklist attached to this directive as "Attachment C" titled "*Checklist for Closing Formal Administration*" shall be filed with the Clerk of Court at the time the Petition for Discharge is filed.
- 4. This directive shall become effective June 1, 2018 and shall remain in effect until further order of this court.
