**IN RE: REFERRAL OF DIVISION H JUVENILE DEPENDENCY
CASES TO GENERAL MAGISTRATE**

WHEREAS, A General Magistrate has been appointed in Escambia County, one of whose responsibilities is handling juvenile cases; and

WHEREAS, it is advantageous for the division of workload and to streamline the process by which cases are assigned to the General Magistrate that the prior procedure of an Order of Referral to General Magistrate being entered in every case file with the assigned circuit judge later determining what, if any, issues will be addressed by the General Magistrate be modified;

THEREFORE, effective May 1, 2011, it is

ORDERED that:

1. This directive shall apply to all dependency case filings currently assigned to Division “H”. Actions being referred to the General Magistrate shall include all post-disposition proceedings, except any subsequently filed termination of parental rights proceedings;
2. The juvenile cases currently assigned to Division “H” which shall be referred to the General Magistrate are listed below:
