**WHEREAS**, in accordance with Chapter 394.467(4), Florida Statutes, the Court shall appoint any such Public Defender within one day, excluding weekends and Court holidays, it is therefore

- 2. <u>APPLICABILITY</u>: All appointments of counsel shall be made as set forth herein.
