- 2. Mandatory checklists for applicable probate petitions are as follows:
  - Checklist for Opening Formal Administration (Attachment 1)
  - Checklist for Summary Administration (Attachment 2)
  - Checklist for Determining Homestead Status of Real Property in Formal and Summary Administration (Attachment 3)
  - Checklist for Closing Formal Administration (Attachment 4)

Checklists shall not be filed in the court file, but rather, shall be emailed as an attachment to the assigned Division email.
